

Terms and Conditions for shandis.co.za

These Terms and Conditions ("Terms") govern your access and use of shandis.co.za ("Website") and all its subdomains, a platform where models ("Models") create and upload adult content and users ("Users") purchase or subscribe to this content. By using our services, you agree to these Terms. If you do not agree, you may not use the Website.

1. Eligibility

1.1. Age Requirement

- You must be at least 18 years old (or the age of majority in your jurisdiction) to use this Website.

1.2. Legal Compliance

- You must comply with all local laws regarding adult content in your jurisdiction.

1.3. Account Registration

- You must create an account to access or upload content. You agree to provide accurate and complete information during registration.

2. Content Creation and Ownership

2.1. Ownership

- Shandis.co.za retain ownership of the content they created.

2.2. License to the Website

- By uploading content, Models grant the Website a non-exclusive, worldwide, royalty-free license to host, display, and distribute the content for platform operations.

2.3. Prohibited Content

- Models may not upload:
 - Content involving minors.
 - Non-consensual acts or exploitation.
 - Content that violates copyright or intellectual property laws.

- Content involving illegal activities.

2.4. Verification

- Models must verify their identity and age before uploading content.

3. Content Purchasing and Usage

3.1. License to Users

- Users who purchase content receive a limited, non-transferable license to view the content for personal use only.

3.2. Prohibited Actions

- Users may not:
 - Share, resell, or redistribute purchased content.
 - Attempt to bypass content paywalls or security features.

4. Payments and Fees

4.1. Revenue Sharing

- Models will receive a certain specific percentage of revenue generated from their content, with the remainder retained by the Website as a service fee.

4.2. Refund Policy

- All purchases are final. Refunds are provided only in cases of technical errors where content cannot be accessed.

4.3. Payment Processing

- Payments to Models and purchases by Users are processed through secure third-party payment systems.

5. Community Guidelines

5.1. Respectful Conduct

- Users and Models must engage respectfully. Harassment, threats, or abusive behavior is strictly prohibited.

5.2. Prohibited Activities

- Hacking, spamming, or attempting to compromise the Website's security or operations is forbidden.

6.1. For Violation of Terms

- The Website reserves the right to terminate accounts for violations of these Terms.

6.2. Voluntary Termination

- Users and Models may terminate their accounts at any time. However, Models must ensure they have withdrawn all earnings before terminating.

- The Website implements security measures to protect Users' and Models' information. However, no system is entirely secure.

- Users and Models agree to indemnify the Website against claims arising from their use of the platform.

- These Terms are governed by the laws of South Africa.

9.2. Arbitration

- Disputes must first be resolved through informal discussions. If unresolved, disputes shall be settled by binding arbitration.
